#### FOREWORD BY THE MINISTER OF FINANCE -

NAVID SABERIN

Minister of Finance



We are pleased to present Liberland's 2023 financial statement.

This year marked the most crucial milestone on Liberland's path to developing a fully sovereign country thus far. This is partially reflected in the revenues, which surpassed those of any previous years.

Firstly, on the occasion of our 8th Anniversary, we successfully launched the first decentralized autonomous government (DAG) in the world. This allows all citizens to be shareholders of our country's sovereignty, similar to a traditional corporate structure. Power is divided between Liberland's governance token and share in Liberland (LLM), and the token that fuels, validates, and protects Liberland's blockchain (LLD). Both will be freely traded in 2024. Secondly, our mission towards settlement came to fruition when we officially opened the first border crossing between Liberland and Croatia on 6th August 2023, allowing anyone with Schengen Area access to enter Liberland freely. As a result, we implemented rules simplifying how citizens and E-Residents can participate in the ongoing mission and settle their parcels of land based on merit holdings. The potential for settling this beautiful and strategically situated area is almost infinite. It is now up to all Liberlanders to decide what the freest country in the world will look like.

With that being said, we have had a permanent population in Liberland since 6th August, fulfilling even the last of the Montevideo criteria for defining a country. This does not mean we are not on a mission towards international recognition; Liberland is engaging in more state-to-state level discussions, and a few more countries have recently recognized us.

The outlook for the upcoming year, amid ongoing decentralization and immigration onto the land, is more than promising. I invite all Liberlanders and Liberland supporters to participate in this everimportant mission.

## FINANCIALS SUMMARY

The total Liberland **income** has reached the amount of **USD 1 571 907** in calendar year 2023 (note: "USD" means "USD equivalent" recalculated to USD with the exchange rate valid on the day of each transaction). This total income is represented by voluntary taxes, contributions, and E-Residency programme revenues.

With **total expenses of USD 1 560 274**, total cash income exceeded expenses by **USD 11 633** in 2023. Liberland is undergoing an expansion phase; therefore, the revenues are being reinvested. All of the closing balance by the end of 2023 was held in Bitcoin. Neither public debts nor any other form of bonds were issued in 2023. The Liberland government has no granted power to enforce collecting money from the citizens nor issue public debts on citizens' behalf.

All presented results have been formally consolidated for both Liberland State and Liberland Limited Ltd., a state service provider.




#### 2023 CASH OVERVIEW (USD EQ.)


## FINANCIALS INCOME

The total operating income of **USD 1 571 907** was mainly represented by two major streams. Firstly, **USD 415 282.37** (26.5%) is representing the E-Residency programme, while the remaining part of 73.5% **(USD 1 156 624.63)** is represented by voluntary taxes and contributions from our supporters. Most of them were received over one of the online payment gateways, small cryptocurrency transfers, or via PayPal.


#### **INCOME BY PURPOSE ASSIGNMENT**

All donors who do not wish otherwise are rewarded with Liberland merits at the nominal value 1:1 USD equivalent of her donation, calculated based on the exchange rate valid at the transaction date.

### - FINANCIALS | INCOME PER CURRENCIES —

In 2023, Liberland state income was over 39.04% cryptocurrencies. This number is a bit lower compared to 2022. As in the previous years, most of the state budget is held in cryptocurrencies because both Liberland and its citizens see a bright future for digital assets.

## FINANCIALS EXPENSES

The main portion consisted of expenses tied to the development of our Blockchain, together with our database and the new website of Liberland. The second biggest item was the operations tied to the ongoing settlement on the land. The third biggest item was the ever-present diplomacy, followed by external services mostly tied to the development of the territory itself. The Ark resort is still fulfilling the function of our base in the area and needed some improvements to operate as such; therefore, it was one of the biggest items of our state budget.


The remaining items, such as administration or PR, were all below 10% speaking in relative terms.



Operatng expenses year over year




# LIBERLAND MERITS

The Liberland merit is an unique evaluation token system, rewarding any contribution and energy coming into Liberland for international recognition and settlement in the territory. After registration, anyone can contribute either by donation, by labour or any other acceptable way.

**The total amount of issued Liberland merits was LLM 8 870 728.015** as of 31st December 2023. All contributions and most of the third-party related expenses have been rewarded with merits by 1:1 to USD equivalent unless asked otherwise.

This year we have issued overall **LLM 2 1 76 631.445** out of which **67.8**% was a reward for voluntarily submitted taxes. The remaining **32.2**% was compensation for provided work instead of using our state budget.
