#### FOREWORD BY THE MINISTER OF FINANCE -

Dear Friends of Liberland,

The year 2024 has been another milestone in the continued evolution of the Free Republic of Liberland. As our unique mission in liberty, transparency, and decentralized governance matures, so too does the global community of citizens and supporters that sustains it.

This year, we proudly continued our tradition of holding elections every three months—an ongoing commitment to direct democratic engagement. These elections have been widely attended, and this year saw the election of several notable international figures, further strengthening Liberland's position on the world stage and broadening our network of global allies.

Our dedication to radical transparency took a major step forward as all government expenses were successfully moved onto the blockchain. This makes Liberland the most financially transparent state in existence, where every transaction can be independently verified in real time by any interested observer.

2024 also marked the successful launch of the Liberland dollar (LLD) on public exchanges. More than just a digital currency, the LLD represents the tokenized sovereignty of Liberland—it is both the soul and the fuel of our ecosystem. It enables services, supports governance, and drives engagement across our platform. We were proud to recognize and reward our early adopters with an airdrop, honouring those who laid the groundwork for this new economic paradigm.

The issuance of merits remained at the heart of our value system, fairly distributed in recognition of both voluntary contributions and tangible work. Revenues from E-Residencies, citizen contributions, and strategic treasury operations sustained our budget and funded ongoing development initiatives. Meanwhile, our spending was prudent, traceable, and fully open to public review.

On the physical frontier, Liberlanders have continued to establish a strong presence in a nearby Croatian village—an emerging hub, along with the Ark village in Serbia, that has become a lively base for many of our citizens. Simultaneously, our mapping and surveying efforts within Liberland's territory have advanced steadily, preparing the ground for future settlement and infrastructure.

None of this would be possible without the passion and participation of our citizens, contributors, and friends around the world. Together, we are building not only a nation but a model—one rooted in freedom, cooperation, and technological innovation.

The total Liberland **income** has reached the amount of **USD 1,917,565.65** in calendar year 2024 (note: "USD" means "USD equivalent" recalculated to USD with the exchange rate valid on the day of each trans-action). This total income is comprised of voluntary taxes, contributions, E-Residency programme revenues, market revenues, and treasury operations.

With total expenses of USD 1,885,510.72, total cash income exceeded expenses by USD 32,054.93 in 2024.

Liberland is undergoing an expansion phase; therefore, the revenues are being reinvested. The entire closing balance at the end of 2024 was held in Bitcoin. Neither public debts nor any other form of bonds were issued in 2024. The Liberland government does not have the authority to enforce the collection of money from citizens nor to issue public debts on behalf of citizens. All presented results have been formally consolidated for both Liberland State and Liberland Limited Ltd., a state service provider.



# FINANCIALS

The total operating income of USD 1,917,565.65 was primarily derived from two major sources: our E-Residency revenues and voluntary taxes, amounting to USD 721,087.77 and USD 712,776.59 respectively. Other revenue sources included LLD market-making profit (USDT) of USD 34,701.29, Liberland Market revenues of USD 2,000, LLD pre-sale of USD 305,000, and Treasury operations of USD 142,000.



#### Operating income year over year




#### INCOME BY PURPOSE ASSIGNMENT

# FINANCIALS EXPENSES


The main portion of the 2024 expenses was directed toward IT-related development, including our blockchain infrastructure, internal databases, and the new official website of Liberland. Operations connected to the ongoing settlement efforts on Liberland's territory formed the second-largest category. Diplomacy once again played a crucial role and ranked third in terms of spending. External services, particularly those supporting the territorial development, followed next.

Investments in the Ark resort, which continues to serve as our operational base in the region, remained a significant budget item due to necessary upgrades and maintenance. Other categories, such as Public Relations and Central Administration, stayed under 10% in relative terms, reflecting a lean approach in those operational areas.

### Operating expenses year over year




# FINANCIALS LIBERLAND MERITS
